ISF (Importer Security Filing)



Start date of Liquidated Damage Charges for ISF Non-Compliance

We like to inform you that effective July 9th, 2013 US CBP (Customs and Border Protection) began full enforcement of ISF (Importer Security Filing) and will start issuing liquidated damages against ISF Importers and Carriers for ISF non-compliance.

ISF 10+2 must be filed by importers 28 hours prior loading at origin port. Missing ISF filing for single shipments can cause holds of the entire container as well as high penalties. Please inform your customers accordingly.
